**TITLE 13, CALIFORNIA CODE OF REGULATIONS  
DIVISION 2, CHAPTER 6  
ARTICLE 2.7, SECTION 1159 IS AMENDED TO READ:**

**§ 1159. Routes.**

(a) Narrative listing of routes.

(1) Interstate Highway 5: From the ~~State state~~ of Oregon border to Interstate Highway 210 and from Interstate Highway 605 to Interstate Highway ~~805~~ 8 (north of the city of San Diego) and from the border of Mexico to Interstate Highway 805.

(2) Interstate Highway 8: From the ~~State state~~ of Arizona border to Interstate Highway ~~805~~ 5.

(3) Interstate Highway 10: From the ~~State state~~ of Arizona border to Interstate Highway 605.

(4) Interstate Highway 15: From the ~~State state~~ of Nevada border to Interstate Highway 8.


(5) Interstate Highway 40: From the ~~State state~~ of Arizona border to Interstate Highway 15.

(6) State Route 57: From Interstate Highway 210 to Interstate Highway 10.






(2) Area maps
