Carrier Inspection

- Conducted at the Principal Place of Business by CHP Motor Carrier Specialist personnel.
- Determines compliance with Controlled Substances and Alcohol Testing requirements contained in Title 49, Code of Federal Regulations (CFR), Parts 382 or 655, and Title 49, CFR, Part 40.
- Inspections for carriers subject to Part 382 include Drug and Alcohol Clearinghouse compliance.



Applicability Title 49, CFR, Part 382

Drivers of a commercial motor vehicle:

- Gross vehicle weight rating (GVWR) or gross vehicle weight, greater than 26,000 pounds.
- Gross combination weight rating or gross combination weight, greater than 26,000 pounds.
- 16 or more passengers.
- Hazardous materials requiring placards.



Applicability Title 49, CFR, Part 382 *(continued)*











Mandate – Title 49, CFR, Part 382 Drug and Alcohol Clearinghouse

- 1/6/2020 "good faith effort" previous employer inquiry <u>and</u> Drug and Alcohol Clearinghouse queries.
- 1/6/2021 Annual queries.
- 1/6/2023- Drug and Alcohol Clearinghouse queries.
 - A "good faith effort" inquiry is still required for prospective drivers subject to other USDOT drug and alcohol testing programs (Transit-Railroad-Aviation) not subject to Title 49, CFR, 382.



Drug and Alcohol Clearinghouse Compliance

- Registered.
- Required queries performed.
- Consent for limited queries are on file.
- Required reporting is conducted.



Common Issues

- Drivers performing safety sensitive functions prior to completing a pre-employment query.
- Annual queries not performed on all drivers.
- No queries completed.
- Not registered.



Compliance Ratings

- Failure to comply with Drug and Alcohol Clearinghouse requirements will result in an unsatisfactory safety compliance rating.
- A detailed report will be provided outlining the violations and steps necessary to gain compliance.
- A reinspection will be conducted in 100-120 days to determine compliance.

Return-to-Duty Process

* Can perform safety-sensitive functions once they have a negative return-to-duty test result.



On-Highway Enforcement

 When a driver is prohibited from performing safety-sensitive functions, they are to be declared out-of-service until the prohibition is removed from the Drug and Alcohol Clearinghouse.



On-Highway Questions

- Is the driver prohibited in the Drug and Alcohol Clearinghouse?
- If yes, what is the GVWR of vehicle the driver is operating?
- Is the driver engaged in *interstate* or *intra*state operations?
- Is the driver a current or former holder of a commercial driver license?



Applicability

 Drivers of a commercial motor vehicle with a GVWR greater than 26,000 pounds in both *inter*state and *intra*state commerce are prohibited from performing a safety-sensitive function until they complete the return to duty process.





Applicability (continued)

 Restrictions to drivers of commercial motor vehicles with a GVWR rating greater than 26,000 pounds apply to both current and former holders of a commercial driver license.







Applicability (continued)


 Drivers of a commercial motor vehicle with a GVWR less than 26,000 pounds, but greater than 10,000 pounds, in *interstate* commerce are prohibited from performing a safety-sensitive function until they complete the return to duty process.





Applicability (continued)

 Restrictions to drivers of commercial motor vehicles with a GVWR less than 26,000 pounds only apply to those who currently hold a commercial driver license.





Excluded Drivers

- The out of service declaration would not apply to:
 - Former commercial driver license holders in <u>interstate</u> or <u>intrastate</u> commerce operating a vehicle with a GVWR of 26,000 pounds or less.
 - A commercial driver license holder in <u>intrastate</u> commerce operating a vehicle with a GVWR of 26,000 pounds or less.
