# WHAT IS THE CIEP?

- CIEP is a cooperative effort between the CHP and the Federal Motor Carrier Safety Administration.



# WHAT IS CIEP?

- The primary objective of the CIEP is to reduce large truck fatalities, and the number and severity of commercial motor vehicle collisions through public education and awareness.
- This program is available statewide.



# CIEP HISTORY

- In 1999, as a result of multiple high-profile commercial motor vehicle involved fatalities, the CHP recognized the need for better communication between the commercial industry and the CHP.
- Members of the CHP collaborated and a plan was created to establish the CIEP.



# CIEP HISTORY

- The CIEP was designed to educate California's commercial trucking industry regarding driver safety, and encourage voluntary compliance with state and federal laws and regulations.





# CIEP HISTORY

- The CIEP is a continuous educational program designed to provide information and safety awareness to everyone operating commercial vehicles.
- It means...a PARTNERSHIP between you and us!

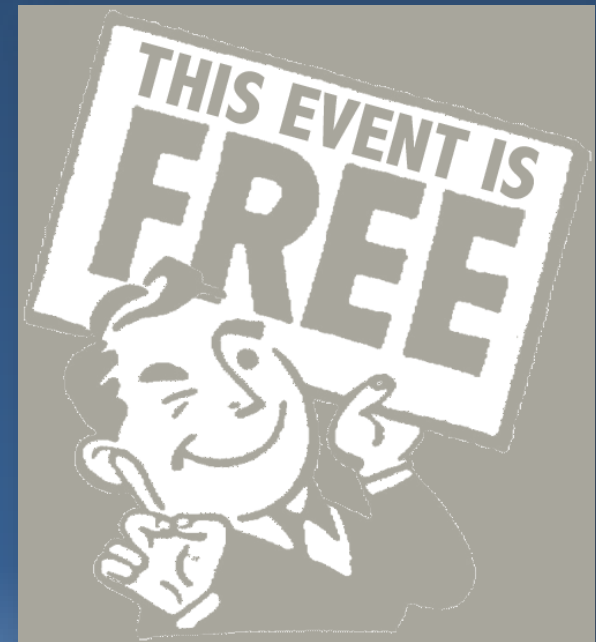
# CIEP PRESENTATIONS
