The CIEP offers your employees, drivers, supervisors, and managers essential training in a variety of areas, including:

- · Seat belt use
- · Sharing the road
- · Rules of the road
- · Out-of-service criteria
- North American Standard Level I vehicle inspections
- Pre-trip inspections
- Transporting hazardous materials (Shippers/Carriers)
- Hours-of-service regulations (electronic logging devices/log books/time cards)
- Reporting highway emergencies
- Farm labor vehicle requirements
- Compliance with Controlled Substances and Alcohol Testing requirements
- · Passenger vehicle inspections
- Human trafficking

Presentations vary from one (1) hour to eight (8) hours. You have the option of receiving the presentations at your facility or another agreed upon location at no charge to you.

In 1999, the CHP recognized the need for better communication between the commercial industry and the CHP. Their primary mission was to provide industry a local commercial contact person and assist with ongoing commercial educational and traffic safety programs. The program has been implemented statewide with Division coordinators and associate instructors.



#### Introduction


