If you are the highest bidder on the vehicle(s) you selected, they will be awarded in the order in which you have chosen on this bid sheet (1<sup>st</sup>, 2<sup>nd</sup>, etc.). You will only be awarded the amount of vehicles you have listed on line #1.

Print name, address, city, state, zip code and phone number. List home, cell and work telephone numbers.

Sign and date bid sheet, seal in envelope then place in bid box. Bids will be collected and tallied at 2 P.M. each Wednesday in West Sacramento and at 4 P.M. each Monday in Torrance.

CONDITIONS OF SALE

**VEHICLE INSPECTION:** All bidders will be allowed to inspect and start each vehicle they intend to bid for; however, no vehicle may be driven around the inspection area. Bids will be collected and tallied at 2:00 P.M. each Wednesday in West Sacramento and 4:00 P.M. each Monday in Torrance.

**VEHICLES:** All vehicles are offered for sale “as is, where is.” The State of California makes no warranty, either expressed or implied, as to the condition of the vehicle offered for sale. The State reserves the right to withdraw or add any vehicles from the sale inventory prior to the start of each sale. The State of California’s equity in the vehicle shall pass to the successful bidder at the time the buyer pays for the vehicle. Items are being sold as is and where is. Verification of the description and condition is the responsibility of the bidder. All sales are final.

**SMOG DEVICE:** Pursuant to California Vehicle Code 24007.5 notice is given that all buyers must obtain a certificate of compliance for smog control devices prior to registration. Purchase by dealers and vehicles sold for dismantling or for exclusive off-highway use are exempted from these requirements.

**PAYMENTS:** *PAYMENT IS TO BE MADE BY CERTIFIED OR CASHIERS CHECK ONLY, MADE PAYABLE TO THE CALIFORNIA HIGHWAY PATROL, BEFORE VEHICLE OR PROPERTY IS RELEASED TO BUYER.* NO, “down payments” or “partial payments” will be accepted. Payment must be made no later than three working days after notification, unless prior arrangements have been made, or the bid may be rejected. Vehicles purchased by out-of-state buyers will be subject to the current rate of sales tax on the final purchase price.

**ALL SALES ARE FINAL AND THE STATE WILL NOT MAKE ANY ADJUSTMENTS OR REFUNDS.** Sales tax will be added to the purchase price for all vehicle sales at the time of registration by the Department of Motor Vehicles. Sales tax will be collected at time of sale for vehicles that will be registered out of state.

**DELIVERY:** Buyers will take delivery of vehicle(s) after payment has been made. When buyer receives the official receipt, it will be accompanied by the key(s) to the respective vehicle and a “no fee” moving permit which will permit the buyer to move the vehicle for a limited period (one day). Permanent registration must be obtained from the Department of Motor Vehicles.

Vehicle service records are not available.
