




#### DUI Arrests: 2005 - 2015

- Median age: 31 years


## 2015 DUI Arrests by Age




# DUI Convictions of DUI Arrests in 2014

- Median BAC level: 0.16%




## Adjudication of 2014 DUI Arrests




# 2014 DUI Convictions by DUI Offender Status




## Court-Ordered Postconviction Sanctions of 2014 DUI Convictions




## Long Term Recidivism Rates by DUI Offender Status of the 2005 DUI Offenders




# 5-year Recidivism Rates of DUI Offender Groups

## 2014 Alcohol- and Drug-Involved Drivers in Fatal/Injury Crashes by Prior DUI Convictions

- 18,325 alcohol- and drug-involved drivers in crashes
- In **fatal** crashes: 77.5% no DUI priors
- In **injury** crashes: 61.5% with DUI priors





Total Number by County




As a Percentage of DUI Convictions by County
