527.8 Temporary Restraining Order, employer request for issuance.

14613.7 Reporting requirements, crimes and criminally caused property damage occurring on state property.

14685 Rules and regulations, violation on state property (misdemeanor).

18935 State Services Exams, disqualifying factors.

19572 Discipline, causes for discipline of state employees.

19994.31 Prohibition of smoking, in state buildings/vehicles.

Penal Code (continued)

- 118 **Perjury**, testifies, declares, deposes or certifies willfully under oath information as true that he/she knows to be false.
- 148 **Resisting arrest**, delaying or obstructing officer.
- 148.1 **Bomb threat**, false report of placement of bomb, or explosive in a public or private place.
- 148.9 **False impersonation**, any person representing or identifying to a peace officer as another or fictitious person.
- 169 **Picket/parade**, near a court with the intent to obstruct justice.
- 171b **Possession of a deadly weapon**, within any state or local public building or at any public meeting.
- 171c **Possession of a loaded firearm**, within or on the grounds of the State Capitol.
- 171d **Possession of a loaded firearm**, within or on the grounds of the Governor's Mansion or any Legislative Member's residence.
- 171e **Examination of firearms**, authorization to examine firearms carried on a person or in a vehicle when on state grounds.
- 171f **Disruption of official business**, within the State Capitol.
- 172 **Sale of intoxicants**, on or near state prisons, youth authority institutions or other specified state and federal properties.
- 182 **Conspiracy**, two or more persons conspiring to commit any crime.
- 211 **Robbery**, taking of personal property by means of force or fear.
- 240 **Assault**, attempt with ability to violently injure another person.
- 242 **Battery**, use of force or violence upon another person.
- 403 **Willful disruption**, of any assembly or meeting.
- 404 **Riot**, use of threat of force or violence by two or more persons.
- 404.6 **Intent to cause a riot**, urging a riot or urging others to commit acts of force or violence.
- 405a **Lynching**, taking a person by means of a riot from the custody of a peace officer.
- 407 **Unlawful assembly**, two or more persons assembled to do an unlawful act in a violent, boisterous or tumultuous manner.

Penal Code (continued)

- 409 Refusal to disperse**, persons remaining present at the place of any riot, or unlawful assembly after being lawfully warned to disperse.
- 409.5 Area closures**, a peace officer may close an area wherever a menace to public health or safety is created by a calamity.
- 415 Disturbing the peace**, by means of fighting, loud and unreasonable noise or use of offensive words likely to provoke violence.
- 422 Threat**, to commit a crime resulting in death or great bodily injury.
- 459 Burglary**, entry of dwelling with intent to commit larceny.
- 469 Unauthorized duplication of keys**, or possession of such keys, belonging to state, county, city, or public school district property.
- 470 Forgery**, defraud, alter or counterfeit signature of another person or fictitious person on a bill, note, document or the like.
- 470a Counterfeit driver's license**, or state issued ID card, alteration, falsification, duplication or forgery in any manner.
- 470b Facilitation of forgery**, use of counterfeit driver's license or ID card.
- 472 Counterfeit state seal**, or seal recognized by the state.
- 484 Theft**, defined.
- 487 Grand theft.**
- 488 Petty theft.**
- 518 Extortion**, wrongfully obtaining property by use of force or fear.
- 529a Counterfeit Birth Certificate**, or baptism certificate, manufacture, production, sale, or transfer.
- 530 False impersonation**, private or official capacity, so as to receive money or property.
- 556 Advertising on state property**, placement of signs, pictures, transparencies or mechanical devices is prohibited.
- 594 Vandalism**, deface, damage or destroy real or personal property.
- 601 Trespass**, credible to threat to cause serious bodily injury.
- 602(p) Failure to leave**, refusal to leave a public building during other than regular business hours when directed to do so.
- 602.1 intentional interference**, with any lawful business or occupation.
- 640.5 Graffiti**, government property.
- 646.9 Stalking**, willful, malicious, repeated following/harassing.

Penal Code (continued)

- 647 (f)** **Disorderly conduct**, under influence of liquor, drugs, controlled substances, toluene or any combination thereof.
- 647c** **Obstruction of movement**, of any person on any street, sidewalk or public place.
- 653m** **Telephone calls**, annoying, obscene, or threatening.
- 664** **Attempt** to commit any crime.
- 837** **Citizens arrest**, private party may arrest when he/she witnessed or reasonably believes the suspect committed a felony.

Title 13. California Code of Regulations

(Rules applicable to use of state property)

- 1860** **Permits**, demonstration or gathering, structures or equipment.
- 1861** **Prohibited conduct**, loud and unusual noises, obstruction of usual use of state property, present on state property when closed to the public.
- 1862** **Signs, poster, placards, banners**, prohibited if freedom of passage is obstructed.
- 1863** **Decorations**, prohibited on trees, shrubbery, fencing or lampposts.
- 1864** **Fire**, prohibited on state property.
- 1865** **Parking**, State Capitol grounds requires permit issued by the CHP.
- 1866** **Domesticated animals**, must be on leash when in State Capitol Park, prohibited in state buildings and grounds unless guide dog, signal dog, service dog or otherwise authorized.
- 1867** **Wheeled conveyances**, bicycles, roller skates, skateboard and the like are prohibited on state property, special exclusions exist.
- 1868** **Flower beds and lawns**, walking on or through flower beds, or areas where plants, shrubs or trees are located within State Capitol Park is prohibited. Walking on lawns or terraces is prohibited where it is likely to cause damage.

Vehicle Code

- 20** **False Statements**, knowingly made or filed with DMV or CHP.
- 4461(c)** **Disabled person placard**, misuse.

Vehicle Code (continued)

- 13004 Identification card**, possession of canceled, fictitious, fraudulently altered or obtained ID card.
- 14610 Driver's License**, possession of canceled, revoked, suspended, fictitious, fraudulently altered or obtained driver's license.
- 14610.5 Fraudulent DMV examinations**, may not sell or distribute answers to any exam, or impersonate an applicant.
- 14610.7 Illegal alien**, willingly assist such person in obtaining a driver's license or ID card.

Welfare and Institutions Code

- 601 Curfew**, juvenile refusing to comply with parents, guardian, custodian, city or county.
- 602 Juvenile crime**, person under 18 years violating a law of this state or the United States.
- 625 Temporary custody of minor**, without warrant when reasonable cause exists to believe such minor is described in section 601 or 602.
- 626 Release or transport of minor**, officer may release, deliver, to public/private agency or probation officer.
- 626.5 Juvenile court**, transport of minor or written notice.
- 627 Notification of minor in custody**, officer shall take immediate steps to notify parent, guardian, or responsible relative.
- 5150 Mental disorder**, person is a danger to self or others.
