Toxicology Driving Under the Influence (DUI)/Driving Under the Influence of Drugs (DUID)

Eligible Applicants

Local Government, which includes California County and/or City Medical Examiners/Coroner's Offices, and Law Enforcement Coroner's Divisions

Project Performance Period

July 1, 2022 through June 30, 2024

This Request for Application (RFA) provides specific opportunity information for the Cannabis Tax Fund Grant Program (CTFGP) 2022/2023 grant cycle, including important deadlines and details. For all program processes and regulations, please review the **California Code of Regulations (Title 13, Division 2, Chapter 13)** and **other program information posted on the California Highway Patrol’s (CHP) Web site** to ensure all eligibility requirements are met for successful participation in the program.

Funding

An applicant may only submit one Grant Application for each grant opportunity and shall only request the amount of funds necessary to complete the project.

Grant funds shall be used to support new program activities or to augment existing funds, which expand current program activities. Grant funds shall not replace (supplant) any federal, state and/or local funds that have been appropriated for the same purpose and are routine and/or existing state and local expenditures. Supplanting is the deliberate reduction in the amount of federal, state, or local funding being appropriated to an existing program or activity because grant funds have been awarded for the same purpose. It is the responsibility of the grantee to ensure that supplanting does not occur.

NOTE: Grantees shall only have one executed Grant Agreement per grant opportunity at a time.

Match Requirements

This opportunity does not require matching funds.

Project Cost

Requested project costs shall address impaired driving and be directly related to the work identified in the Grant Application. To be permissible, costs must be reasonable, necessary, and expended according to the CTFGP policies, procedures, and regulations. Projects are required to have a realistic and prudent budget that avoids unnecessary expenditures unrelated to the project activities. Final determination of eligibility will be made by the CHP and approved within the Grant Agreement. Please refer Annex A for ineligible expenses.

The information below includes approximate funding amount, project requirements, and cost guidelines.

Project Performance Period

Two Years (July 1, 2022 through June 30, 2024)

Eligible Applicants

Local Government, which includes California County and/or City Medical Examiners/Coroner's Offices, and Law Enforcement Coroner's Divisions

Project Funding

Approximate available funding is \$6 million, with a \$2 million cap per application. Applicant must provide strong justification, measurable goals, and an immediate need for all requested budget items. Project funds shall be used to improve and advance the data collection in Medical Examiner/Coroner's offices/divisions supporting DUI/DUID when a death occurs while the deceased was driving or riding in a motor vehicle, or a result of the deceased being struck by a motor vehicle.

Project Requirements

Medical Examiners/Coroner's projects shall:

- Take biological samples (e.g., blood, urine, tissue, saliva, etc.) from the body of the deceased before it has been prepared for burial to test for **both** alcohol and drugs; and
- Report data collection to the CHP.

In addition to any other required reporting, Grantees shall report the number of deceased persons with alcohol, drugs, or a combination of alcohol and drugs, in their system to the CHP. Grantees shall provide specific data for each fatality, which includes, but is not limited to:

- Name of Investigating Agency;
- Sex of Deceased;
- County;
- Person Type (Driver or Passenger);
- Alcohol Analysis (Blood Alcohol Content [BAC]); and
- Drug Analysis (Drug Name(s), Drug Category(s), and Tetrahydrocannabinol Level).

The above required data collection will help develop a comprehensive picture of the magnitude and characteristics of impaired driving. In addition, the data will help improve the standardization of crime laboratory testing for drug-impaired driving cases.

Eligible Project Categories

The categories listed below are provided as examples and do not constitute all eligible costs.

- **Personnel:** Costs include compensation for salaries and fringe benefits such as annual leave and sick leave for work directly related to the project.

- Staff time for data collection and reporting.
- **Equipment:** Equipment costs include non-expendable, tangible, personal property having a normal useful life of more than one year and an acquisition cost of at least \$5,000 or more per asset (i.e., four identical assets, which cost \$1,250 each, for a \$5,000 total are not considered an equipment purchase). Funds can be used to purchase and/or upgrade forensic laboratory equipment to improve data collection, that meet the following standards:
 - Minimally test for National Safety Council's (NSC) Tier I drug list.
 - Meet NSC analytical thresholds for testing.
 - Equipment item(s) to improve testing capabilities and efforts in the following areas:
 - Testing for concentration of cannabinoids, to include tetrahydrocannabinol (THC), hydroxy-THC, and carboxy-THC.
 - Testing of all traffic cases for NSC Tier I compounds, regardless of BAC.
 - Testing of all drugs.
- **Consultants/Contracts:** Consultant/Contract costs include professional services necessary to carry out the project objectives that are clearly outlined in the grant application. Laboratory accreditation is required for contracts with forensic toxicology laboratories involved in postmortem toxicology. Utilizing an accredited California local government laboratory is strongly encouraged.
