2025 SECOND QUARTER MEETING MINUTES

The Advisory Committee for Persons with Disabilities (ACPD) 2025 Second Quarter meeting was held on May 9, 2025, at 1100 hours. Because not all ACPD members were able to attend in person, the meeting was also held via Microsoft Teams.

OPENING REMARKS:

Captain Serrato opened the meeting by welcoming the attendees and conducting roll call.

- Captain Serrato welcomed SSA Dimassimo and Officer Sandoval as new committee members.
- Captain Serrato notified members that committee member SSA Stefania Montanez resigned from the committee.

AGENDA ITEMS:

Old Business

- Captain Serrato and OT Carlson briefed the committee members on the status of the art
 contest video project being produced by Community Outreach & Marketing Section
 (COMS). This video is intended to be shared both internally within the Department and
 externally with the public. The intent is to showcase the art contest project and its
 profound impact on the folks who participate.
- Captain Serrato thanked AGPA Planinz for assisting with the nomination packet to nominate the ACPD at the Association of California State Employees with Disabilities (ACSED) Disability Awareness Committee (DAC) Award ceremony on June 2, 2025.
- Captain Serrato asked AGPA Planinz for an update on the ACPD and Limited Examination Appointment Program banners, and he related that they will be purchased at the beginning of the next fiscal year.

New Business:

- Officer Mackintosh discussed the 2025 duty roster. All members know their duties and were encouraged to ask for assistance if they have questions or concerns.
- Officer Sandoval asked for a list showing all the Department's vacancies by classification to be able to share at recruitment events.
- Officer Rombouts briefed the committee on the status of 2025 NDEAM jobs resource fair for both northern and southern California. The employment fairs will take place in southern California on October 2, 2025, and in northern California on October 9, 2025.

- When discussing the NDEAM flyer, PSDSI Mezger offered to create the flyer and work
 with Officer Sandoval before submitting it to AGPA Planinz, and AGPA Planinz
 cautioned them to submit the NDEAM flyer soon so that COMS can have ample time to
 design the flyer.
- When the topic of traveling to the two NDEAM jobs resource fairs was brought up, AGPA Planinz reminded members to submit requests for travel approval with ample time prior to scheduled ACPD events. Officer Mackintosh will help handle this request.
- Captain Serrato asked for an update on the art contest, and OT Carlson briefed the
 committee members on the current status of it, and she was encouraged to remind
 participants to submit their nominations in a timely manner. The ACPD members will
 vote once all submissions have been received.
- Officer Thomas reminded the committee members to submit a story or article for the AWARE NEWS newsletter by May 16, 2025.
- Captain Serrato will submit a Solid Realistic Ongoing Verification Training regarding the ACPD.
- The members were briefed on the importance of the Department's Disability Awareness Award and were asked about ways to encourage submissions. Officer Thomas suggested a flyer be made when nominations start, and OT Carlson also suggested creating a banner on the Department's SharePoint to bring awareness to such an important award. Nominations will begin October 1, 2025.
- When discussing progress on redeveloping the ACPD's intranet and internet pages, AGPA Planinz related he was going to follow up on the status, and SSA Dimassimo offered to take this on as part of her duties and work with EOAS on the update.

Round Table:

- Captain Serrato invited committee members located in the Sacramento region to attend the ACSED DAC Award ceremony on June 2, 2025, at the May Lee State Office Complex. So far SSA Dimassimo, OT Carlson, and Captain Serrato have committed to attending the event and representing the ACPD.
- Officer Sandoval asked if there was a listing showing job vacancies by classification to be able to share at different recruitment events, and SSA Dimassimo related SSES can assist.

- Action Item: Captain Serrato requested that AGPA Planinz collaborate with SSES to create a list that can be shared with committee members to facilitate recruitment purposes.
- Captain Serrato reminded everyone that the Special Olympics Law Enforcement Torch Run will soon be kicking off. He encouraged members to reach out to local area offices to partner with them, take photographs, and share them with Officer Sandoval. So far, SSA Dimassimo and OT Carlson expressed interest in participating in the local run.
- Captain Serrato invited members in Sacramento to run with the Dublin Area on June 26, 2025.
