A BRIEF DESCRIPTION OF THE ASSEMBLY, PROTEST, DEMONSTRATION, OR INCIDENT

On June 8, 2025, at approximately 1555 hours, California Highway Patrol Southern Division Special Response Team (SRT) and Inland Division SRT, responded to the US Route 101 at Los Angeles Street, located within the city of Los Angeles and the county of Los Angeles, in response to “Anti-Immigration and Customs Enforcement (ICE)” protesters unlawful access onto US Route 101.

At approximately 1600 hours, SRT members were met with assaultive resistance, which included multiple protesters throwing items such as rocks, chunks of concrete, bottles, frozen water bottles, bottles with unknown liquid substances, street signs, electric scooters, bicycles, flammable liquids with various items on fire to accelerate the fires. SRT personnel also had fireworks thrown at them causing temporary tinnitus in their ears.

SRT grenadiers utilized 40 mm Foam Baton’s, 12-Guage Shotgun with Kinetic Energy Bean Bag Rounds, 40 mm Aerial Distraction Rounds, Chlorobenzalmalononitrile (CS), and Tactical Smoke when they identified specific subjects and or groups assaulting officers. At no point were specialty munitions or chemical agents utilized indiscriminately in the crowd of protesters.

This incident lasted for approximately 8-9 hours.

OTHER DE-ESCALATION TECHNIQUES OR OTHER ALTERNATIVES TO FORCE ATTEMPTED

The following orders were broadcast three times prior to the operation utilizing a California Highway Patrol vehicle's public address system: I am Lieutenant Martin Geller, a peace officer for the California Highway Patrol. I hereby declare this to be an unlawful assembly, and in the name of the people of California, command all those assembled at US Route 101 and Los Angeles Street to immediately disperse, which means to break up this assembly. If you do not do so, you may be arrested or subject to other police action. Other police action may include the use of less lethal munitions, chemical agents, police batons, tasers, or any force deemed necessary, which could cause significant risk of serious injury to those who remain. Penal Code section 409 prohibits remaining present at an unlawful assembly. If you remain in the area just described, regardless of your purpose, you will be in violation of Penal Code section 409. The dispersal route is the Los Angeles Street on ramp from the southbound US Route 101.

Throughout the operation, SRT personnel gave protesters continuous orders to leave the area. The orders included notice of proper direction of exit, along with advisements that if protesters left the area, they would not be subject to arrest. SRT personnel deployed 160, 40 MM Aerial Distraction Rounds on this date.
