## TO BE CONSIDERED BEFORE WAIVING

It may require up to 12 months to complete processing of physical ability testing, psychological evaluation, medical examination, background investigation, and review before an applicant can be considered for possible appointment. When a waiver is received, all processing is halted. If you waive a class offer, a new physical ability, psychological evaluation, medical examination and additional time may be required. **Do not sign, complete or return this unless: (1) you wish to have everything stopped for 60 days (active); (2) you wish to be taken off the eligibility list (inactive).** 

## **EXPLANATION OF WAIVERS**

- 1. Submission of an active waiver will remove your name from consideration for up to 60 days. The California Highway Patrol will recontact you at a later date.
- 2. Submission of an inactive waiver will place your name on the inactive list. To be recontacted you must write to the California Highway Patrol requesting your name be restored to the active list.
- 3. Upon receipt of a third waiver, your name will be removed from the eligible list and you can no longer be considered for appointment. It will be necessary for you to qualify in another examination to be considered for appointment.
- 4. Your eligibility is good for the life of the list, normally 24 months from the date the list is established. If the list has expired, your name cannot be restored; it will be necessary to qualify in another examination. (If you have been in the military service since the list was established, it may be possible to extend your eligibility.)
